### Bulgaria Outdoor Power Supply Monopoly

What is a Bulgarian power exchange?

The Bulgarian power exchange is a monopoly platform operating major part of the power market in the country. According to the Energy Act only one license can be issued for organizing a power exchange in Bulgaria. IBEX is the mandatory channel through which generators with installed capacity of 500 kW or more have to sell their electricity.

What is the main source of electricity in Bulgaria in 2022?

Coal energy was the main source of electricity production in Bulgaria in 2022. It accounted for over 45 percent of total electricity generation. Nuclear energy ranked second, making up 35 percent of total production.

How is electricity used in Bulgaria?

Electricity can be generated in two main ways: by harnessing the heat from burning fuels or nuclear reactions in the form of steam (thermal power) or by capturing the energy of natural forces such as the sun, wind or moving water.

What is the electricity market like in Bulgaria?

The electricity market in Bulgaria is in a process of liberalization, which started back in 2004 and still continuous. The market consists of two segments – a segment with regulated prices and a segment with freely negotiated prices or the so called "free market".

How much electricity does Bulgaria export a year?



In the past year, the export of electricity reached record levels of 12.2 TWh, which is an increase of 39% compared to the previous year, ranking Bulgaria third among the largest exporters of electricity in the European Union. Electricity production capacities meet consumer demand in Bulgaria and enable exports to neighboring markets.

Does Bulgaria have a nuclear power market?

The Bulgarian electricity market is in transition, but nuclear power is expected to retain its large share of generation capacities. The government intends to decrease its coal power capacity to gradually replace it with renewable power capacity.


